Dear Pet Owner,

Please take a few minutes to read our pet rules. These rules are designed to protect not only you and your pet, but other patrons and their pets as well.

A \$25 non-refundable deposit and a fee of \$5 per day per pet will be assessed up to \$100 per month.

A current health certificate is required by Georgia and Florida Law. The certification must verify your pet is free from infectious disease. For dogs and cats, we also require a current rabies certificate. The expiration date on these certificates must not be prior to departure date of the pet owner. If neither certificate is available at the time of check-in, the document (s) must be obtained and presented to the Front Desk by the end of the next business day.

General Rules

- Allowable pets include domestic cats, dogs, birds and fish. There will be no additional charges for fish.
- Maximum number of pets per family, per room/cabin is two. Specifically excluded pets are pit bulls, ferrets, insects, snakes and other reptiles.
- Owners must comply with USAIC Regulation 215-2, Para 6c(6) and 6d(8). When leaving your guest room, please confine your pet(s) in your pet carrier. It is the guest's responsibility to ensure that pets are caged when guests are not in the room. Guests rooms will be entered daily for sanitary and security reasons where applicable. Pets must be caged whenever lodging employees or agents; contractors or other post personnel require access to the guest room. Except for a bona fide emergency in which property or life is in peril, employees or agents will not enter your room without first receiving assurance that your pet (s) are caged. This may result in decreased housekeeping or maintenance service if we are unable to enter your room due to an un-caged pet.



- Pets are not permitted to run freely and are prohibited from stairways, lounges, laundry areas playgrounds, picnic areas, pools and fishing piers. Pets may not be tied up outside any facility. Pet owners may walk their pets using the designated grassy areas. Guests must clean up pet feces from outside area and properly dispose in dumpsters in a sealed bag
- Pet owners are responsible for damages caused by their pet(s). Rooms are inventoried prior to and after each occupancy. Damages discovered as a result of your pet(s) will be billed to you at the current replacement cost. Pet owners are also responsible for revenue losses incurred if, after vacating your room, we are unable to rent the room as scheduled because of conditions caused by your pet (i.e. urine odors, unusual amounts of animal hair, etc.) Collection actions will be taken if extra cleaning or damages are discovered after your departure.
- Pet owners that house pets in a non authorized guest room/cabin will be charged a \$100 fee.
- The comfort and safety of other guests is important. Complaints from other guests about your pet, (i.e. barking or running loose) shall not exceed one complaint. Should Management receive more then one complaint, the pet owner will be required to make alternate lodging arrangements for their pet(s).

Pets in the RV park are exempt from the deposit and daily pet fee.

All rules and regulations will apply to your pet and you will be required to sign the release form.

Service Animals with proper ID cards will be exempt from the \$5.00 pet fee

All rules and regulations will apply to your service animal and you will be required to sign the release form.
