**AGREEMENT**

I acknowledge receipt of, and responsibility for, the slip listed above and certify that they were received by me in a serviceable condition. I agree to pay in full the amount listed in the total due and that if I charge this to my room I agree to pay the bill in full prior to checking out. I understand that I am accountable for this slip while in my custody and agree to pay for or replace any article lost or not returned in a serviceable condition. If I cannot replace the lost or damaged item(s), I agree to reimburse the Destin Army Recreation Area, in cash the amount equal to the current retail or repair cost of the above article(s), plus any late charges that may be incurred. If I do not, or cannot, make cash payment I hereby consent and agree to reimburse by checkage of my military pay and allowances in accordance with the Military Pay Procurement Manual Chapter 7, tables 7-7-3 through 7-7-6 of DOD pay entitlements manual, the amount equal to the current replacement or repair cost of the above articles.

1. I agree to indemnify and hold harmless the Destin Army Recreation Area and its staff, and the U.S. Army, and its members, agents and employees from all claims, damages, losses, injuries and expenses arising out of or resulting from rental or usage of a slip or the facility, Destin Army Recreation Area is not liable for any loss due to theft, vandalism, fire, collision, natural disasters or water levels which may cause damage to or destroy Renter's boat, watercraft or personal property stored therein.
2. I understand that all slip reservations must be paid for in advance and the renter hereby acknowledges that there is no refund of rent if for any reason the rental period is terminated early.
3. Trailer storage may not exceed seven (7) days.
4. The gate to the private marina shall remain locked at all times. Renter and only those persons in Renter's group are entitled to access the private marina through the gate. Renter takes full responsibility for persons in Renter's group or guest(s) while at the private marina, including, but not limited to, the docks or the walk ramp.
5. Renter shall not sublet the boat slip or allow other persons to use the boat slip without the prior written consent of the Destin Army Recreation Area.
6. Renter shall not use any boat slip other than that boat slip which is the subject of this Agreement and shall not change boat slips at any time during the term of this Agreement.
7. Renter further acknowledges that one boat or two personal watercraft may occupy a single boat slip. Renter shall not tie a boat or watercraft so tightly to the boat slip that there is damage to the boat slip. Renter is responsible for such damage to the boat slip or for damage to any other boat or watercraft in the marina area caused by Renter, or Renter's boat or watercraft.
8. Renter and the persons in Renter's group shall not place chairs, ice chests, towels, etc., or in any other manner obstruct other persons from being able to pass by on the marina docks or walk ramp. Nothing is to be thrown overboard and all trash must be placed in the dumpster.
9. Renter understands that vessels must properly be secured and they are responsible for any damage caused by their vessel and that the Destin Army Recreation Area personnel may board and move your vessel at any time in the interest of safety and security.
10. In the event of a severe storm Destin Recreation Area personnel may ask that all vessels be moved from the marina. Renters must have vessels removed or the Destin Recreation Area may remove the vessel at the owners expense.
